## **General Assembly Takes Spring Break**

While the Senate and House did not take any formal votes last week, more than 300 bills were filed. The Senate filed 268 bills, while the house filed 46. The big push to file bills in the Senate was due to their bill filing deadline of April 6<sup>th</sup>. This meant that all Senate bills for the session had to be introduced by April 6<sup>th</sup>. The House has extended its bill filing deadline to May 11<sup>th</sup>. This gives House members another month to get their bills drafted and filed.

Once bill filing deadline has passed, the next important date on the legislative calendar is the Crossover deadline which is May 13, 2021. This is a significant date for all non-budget and non-finance bills. The substantive (non-money) House and Senate bills must pass through either the House or Senate in order to remain eligible for consideration. For example, a Senate or House bill must go through committee(s) and pass 2<sup>nd</sup> and 3<sup>rd</sup> readings to remain eligible for further consideration during the 2021-2022 legislative session.

## **Bills Introduced Last Week**

As a result of last week's bill introductions, we have added more than a dozen bills to our bill tracking list. Newly introduced bills include, the Governor's Budget (S622), and several broadband expansion bills (H 384, S547, H 476, S517, S523). Senators Woodard of Durham County and Senator Waddell of Mecklenburg County are the primary sponsors for <u>Senate Bill 479 - 2% COLA for State Retirees</u>.

Local government retirees, we continue to work with legislators to get legislation introduced to address local government retirees' pension value.
